

CHARGE I: VIOLATION OF THE UCMJ, ARTICLE 85 (DESERTION)

SPECIFICATION: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, on or about 3 July 2005, without authority and with intent to remain away therefrom permanently, absent himself from his unit, to wit: USS ALBUQUERQUE (SSN 706), then located at Naval Submarine Base, New London, Connecticut, and did remain so absent in desertion until he was apprehended on or about 26 March 2006.

CHARGE II: VIOLATION OF THE UCMJ, ARTICLE 92 (FAILURE TO OBEY GENERAL ORDER OR REGULATION)

SPECIFICATION: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, onboard USS ALBUQUERQUE (SSN 706), on divers occasions between on or about 1 July 2005 and 26 March 2006, violate a lawful general order regulation, to wit: SECNAVINST 5510.36, Department of the Navy (DON) Information Security Program (ISP) Regulation, dated 17 March 1999, by wrongfully failing to properly safeguard and store classified CONFIDENTIAL and SECRET information in his possession, by wrongfully possessing and storing said classified information at locations not authorized for such storage.

CHARGE III: VIOLATION OF THE UCMJ, ARTICLE 106a (ESPIONAGE)

SPECIFICATION 1: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, at or near Manama, Bahrain, on or about March 2005, on divers occasions, with intent or reason to believe it would be used to the injury of the United States or to the advantage of a foreign nation, attempt to communicate, deliver or transmit classified CONFIDENTIAL and SECRET information relating to the national defense, to a representative, officer, agent or employee of a foreign government.

SPECIFICATION 2: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, at or near Vienna, Austria, on or about 19 October 2005, with intent or reason to believe it would be used to the injury of the United States or to the advantage of a foreign nation, communicate, deliver or transmit classified CONFIDENTIAL and SECRET information relating to the national defense, to a representative, officer, agent or employee of a foreign government.

SPECIFICATION 3: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, at or near Mexico City, Mexico, on or about 19 March 2006, with intent or reason to believe it would be used to the injury of the United States or to the advantage of a foreign nation, communicate, deliver or transmit classified CONFIDENTIAL and SECRET information relating to the national defense, to a representative, officer, agent or employee of a foreign government.

CHARGE IV: VIOLATION OF THE UCMJ, ARTICLE 134 (FEDERAL ASSIMILATIVE CRIMES ACT VIOLATION OF 18 USC 793(b))

SPECIFICATION 1: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, on board USS ALBUQUERQUE (SSN 706), from on or about May 2005 to on or about July 2005, for the purpose of obtaining information respecting the national defense of the United States of America, with intent or reason to believe that the said information was to be used to the injury of the United States or to the advantage of a foreign nation, violate Title 18, United States Code, Section 793(b), by knowingly and willfully making an electronic copy of classified CONFIDENTIAL and SECRET information connected with the national defense.

SPECIFICATION 2: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, at or near Vienna, Austria, on or about August 2005, having unauthorized possession of, access to, and control over information relating to the national defense of the United States of America, which information the said Fire Control Technician Third Class Ariel J. Weinmann had reason to believe could be used to the injury of the United States or to the advantage of a foreign nation, violate Title 18, United States Code, Section 793(e), by knowingly and willfully communicating classified CONFIDENTIAL and SECRET information relative to national defense to a person not entitled to receive said information.

ADDITIONAL CHARGE I: VIOLATION OF THE UCMJ, ARTICLE 108 (DESTRUCTION OF MILITARY PROPERTY OF THE UNITED STATES)

SPECIFICATION: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, at or near Vienna, Austria, on or about March 2006, without proper authority, willfully destroy a laptop computer hard drive, of some value, by smashing it with a mallet and cutting off the pins, military property of the United States.

ADDITIONAL CHARGE II: VIOLATION OF THE UCMJ, ARTICLE 121  
(LARCENY)

SPECIFICATION: In that Fire Control Technician Third Class Ariel J. Weinmann, U.S. Navy, Naval Submarine Support Center, Norfolk, Virginia, on active duty, did, onboard USS ALBUQUERQUE (SSN 706), on or about 1 July 2005, steal a laptop computer, military property, of a value of more than \$500.00, the property of the United States Government.
